**Abstract:** The John Grady Historical Collection consists of various types of material that

reflect the history of Plainfield, and to a lesser extent, the surrounding area. The collection includes photographs, postcards, artifacts, and ephemera of Plainfield houses, schools, businesses, organizations, houses of worship, and families.

**Language:** The records are in English.

### **Biographical Information**

John Grady was born in 1948 and grew up in Fanwood, New Jersey in a house his parents had built for them. He continued to live and eventually work in the area, becoming a realtor in Fanwood and nearby Scotch Plains. In 1977, Grady moved to Plainfield and lived for two years on West 8th Street. In 1979, he purchased an 1875 Second Empire style house located at 828

Arlington Avenue. For 30 years, Grady worked on restoring this house to its former glory, winning the first-place award for "Most Authentic Color Scheme for a Residence," a nationwide competition sponsored by Victorian Homes magazine in 1999.

During his time in Plainfield, Grady was active in historic restoration and preservation. In 1982 and 1985 respectively, he wrote the National Register of Historic Places site nominations for the Van Wyck Brooks and Hillside Avenue Historic Districts. Grady was a member of the Historical Society of Plainfield and served as chairman of the Plainfield Historic Preservation Commission. The predecessor to the Commission, a grassroots residents' organization known as the Plainfield Historic Review Committee, is where Grady met Dorothe Pollard. Together they wrote two books on Plainfield: the Arcadia "Images of America" book *Plainfield* in 2001 and the Schiffer publication *Plainfield, New Jersey's History & Architecture* in 2008. Grady moved to Virginia a year later in 2009.

## Scope and Contents

The John Grady Historical Collection spans the years 1840 to 2011, with the majority of the material from and about Plainfield. Surrounding towns such as Fanwood, North Plainfield, and Scotch Plains are represented as well, to a lesser degree. The collection consists of photographs, postcards, blueprints, artifacts, printed material, maps, certificates, clippings, programs, brochures, deeds, correspondence, and ephemera.

Materials of note include the vast number of house photographs, many identified by street address. These records of Plainfield residences are a valuable tool for conducting house histories. Other collection highlights are ephemera and artifacts from Plainfield businesses that no longer exist, such as a business card for the proprietor of the Farmers' Hotel and a Tepper's Department Store charge plate, still in its own case. Finally, the over 1,000 photographs, including images by local photographers Reina Lawrence, John Hoffman, Paul Collier, Guillermo Thorn, and Frank Langhorne, provide visual documentation of Plainfield's history throughout the years.

Four series, the Dix-Lawrence Family Papers, the Reina Lawrence Photographs, Plainfield Families, and the John Hoffman Photographs are separate collections that are considered part of the overall John Grady Collection. Similarly, portions of the Ephemera series are distributed throughout various subject collections but remain part of this collection.

Before being donated to the library, a number of photographs and ephemera in this collection was originally used as visual aids in John Grady and Dorothe Pollard's book *Plainfield: New Jersey's History & Architecture*.

## **Physical Characteristics and Technical Requirements**

The majority of this collection consists of materials, such as paper documents, photographs, and artifacts that do not require any additional technology for access. Negatives and slides would require digitization for easier viewing; at the very least, a loupe and lightbox may be used. DVDs can be viewed via computer in the Plainfield Room.

## **Series Description**

#### Series 1: Houses and Real Estate [1920-2004, undated]

#### **Series Arrangement**

Series 1 is arranged alphabetically by location, when possible, and fills three records boxes, one oversize box, and one roll storage box.

#### Description

Series 1 contains photographs, slides, negatives, and scans of Plainfield and other New Jersey residences, (including John Grady's childhood home in Fanwood and grandparents' home in Cranford), deeds, legal papers, correspondence, surveys, blueprints, clippings, Plainfield Historic District documentation, and real estate listings. Photographs of the Talmadge Mansion, which burned down in 1969, can be found in the Historical Photograph Collection.

#### Series 2: 828 Arlington Avenue House [1875-2008, undated]

#### **Series Arrangement**

Series 2 is arranged by material type, and fills seven folders and part of one oversize box.

### **Description**

Series 2 contains photographs, deeds, legal paperwork, a blueprint, and articles documenting the history and restoration by John Grady of his home at 828 Arlington Avenue in Plainfield.

#### Series 3: Dix-Lawrence Family Papers [1840-2004, undated]

#### **Series Arrangement**

Series 3 has been arranged separately as its own collection with a finding aid. It fills two records boxes, two document boxes, three oversize boxes, and nine archival boxes of various sizes.

### **Description**

Series 3 contains letters, manuscripts, legal documents, receipts, ephemera, artifacts, clippings, scrapbooks, and photographs documenting three generations of the Lawrence family, most notably Katharine Morgan Lawrence, Reina Andrade Lawrence, and Dorothea Dix Lawrence.

### Series 4: Reina Lawrence Photographs [1890-1933]

#### **Series Arrangement**

Series 4 prints are arranged numerically by assigned number and fill four binders; glass plate negatives fill 33 boxes.

#### **Description**

Series 4 contains over 900 photographic prints from glass plate negatives taken by Reina Andrade Lawrence, a member of the Dix-Lawrence family and a photographer of local Plainfield life. Her images include interiors and still lifes, gardens, houses, and portraits.

#### Series 5: Plainfield Families [1860s-1971, undated]

#### **Series Arrangement**

Series 5 has been arranged separately as its own collection with a finding aid. It fills one records box, part of a document box, and part of an oversize box.

### Description

Series 5 represents the portion that John Grady donated to the Plainfield Families Collection. It contains manuscripts, speeches, letters and postcards, journals, report cards, certificates and diplomas, deeds, ephemera, clippings, and photographs documenting various families who resided in Plainfield during the 19th and 20th centuries.

#### Series 6: Photographs and Postcards [1897-2007, undated]

#### **Series Arrangement**

Series 6 photographs are arranged alphabetically by subject, when possible, and fill one records box and one oversize box. Postcards are arranged numerically by assigned number and fill one binder. This series also includes negatives and duplicate postcards.

#### Description

Series 6 contains photographs, slides, negatives, and scans of various subjects including businesses, churches, construction and demolition, downtown Plainfield, parades, people, schools, and train stations. Plainfield photographers include Paul Collier, Guillermo Thorn, and Frank Langhorne.

The 352 unique postcards in Series 5 are of numerous subjects including churches, schools, businesses, houses, and streets. There are also novelty Plainfield greeting postcards.

### Series 7: John Hoffman Photographs [1900-1940]

#### **Series Arrangement**

Series 7 prints are arranged numerically by assigned number and fill one binder; glass plate negatives fill four boxes.

### **Description**

Series 7 contains 107 photographic prints from glass plate negatives, taken by Plainfield photographer John Hoffman. His images depict houses and back yards, carnivals, parades, people, and other views of local life.

#### Series 8: Ephemera and Artifacts [1872-2011, undated]

### **Series Arrangement**

Series 8 ephemera is arranged by subject and fills one document box and part of an oversize box. Please note that approximately two linear feet of ephemera was distributed throughout various subject collections when part of this donation was first acquired. Although this material remains with those collections, it is considered part of the overall John Grady Collection. The artifacts from this series fill one 12"x15" box.

#### Description

Series 8 ephemera is extensive and includes programs, booklets, advertisements, newsletters, catalogs, flyers, invitations, membership cards, and certificates from Plainfield schools, businesses, churches, organizations, and city government.

Series 8 artifacts include pins, patches, an ashtray, a record cleaner, a paperweight, a coin bank, a belt buckle, a metal badge, a shopping bag, a Tepper's charge plate, and a commemorative ribbon.

### Series 9: Printed Material and Maps [1897-2003, undated]

#### **Series Arrangement**

Series 9 printed material is arranged by subject and fills part of a document box and part of an oversize box. Maps are located in Map Collection Boxes 2 and 3.

### **Description**

Series 9 printed material includes Plainfield Chamber of Commerce and New Jersey magazines, published booklets on Plainfield, yearbooks for the Plainfield Academy, sheet music from 1911 commemorating Plainfield High School, and a 1998 NJ Transit Plainfield Station Accessibility Study.

Maps in Series 9 include a shopper's guide map, a map of Plainfield with public school zones (1961), a map of desirable lots in Netherwood (1891), and a map of Plainfield and North Plainfield from the State Trust Company (1925).

#### **Access & Restrictions**

The John Grady Historical Collection is available for research.

Access is restricted to materials prepared by the Local History department staff. All materials must be viewed in the Plainfield Room and may not be removed to another area of the library without permission of the Library Director or designee. Materials must be handled carefully and kept in order. Materials must not be leaned upon, altered, folded, ripped, or traced upon. Marks may not be added or erased from materials. Materials must be returned directly to Local History department staff and inspected before the researcher leaves the Plainfield Room.

One photocopy may be made (by Plainfield Public Library staff) of each document for the purpose of research; official Local History departmental reproduction fees may apply. Permission to publish must be obtained by the Plainfield Public Library Board of Trustees as delegated to the Library Director. Permission to publish does not constitute a copyright clearance. The researcher is responsible for further copyright restrictions. The Plainfield Public Library is not responsible for the misuse of copyrighted material.
