Abstract: The Albert D. Pittis Papers document a small portion of his real estate endeavors in

Plainfield and include legal dockets, property specifications, a blueprint map, and photographs. The collection also contains documentation of his brother Bertram Pittis' membership in the Watchung Nature Club of Plainfield and includes administrative papers, membership records, correspondence, and programs. In addition, the collection includes a family calendar featuring photographs of Pittis

family members from the 1850s through the early 2000s.

Language: The records are in English.

Biographical and Historical Information

Albert D. Pittis (1930-2025), whose family had been in Plainfield since the 1870s, was a lifelong resident of the city. He graduated from Plainfield High School in 1948, earned his Bachelor's degree from Princeton University in 1952, and then went on to receive an MBA from Rutgers University. Albert and his brother Walter managed their father's commercial real estate business in Plainfield, Westfield, and New York City. In addition to his successful professional life, Mr. Pittis was also a dedicated member of the Plainfield community. He served as president and treasurer of the Plainfield Business Association, was a member of the Plainfield Special Improvement District, a founding member and organizer of the Plainfield Outdoor Arts Festival, a long-time member of the Plainfield Cultural and Heritage Commission, and a parishioner of Grace Episcopal Church.

Albert's brother Bertram Pittis and his wife were active members of the Watchung Nature Club of Plainfield, NJ from the 1940s through the 1960s. The Club was founded in 1927 to unite those

interested in nature and the great outdoors and to encourage the conservation of natural resources.

Scope and Contents

The Albert D. Pittis Papers document some of the local real estate holdings of Mr. Pittis and the Pittis Estate on East Front Street and Watchung Avenue. Record types include copies of legal dockets, specifications, indentures, details, and notes concerning alterations to properties abutting the mill race. A copy of a blueprint map shows those properties on East Front Street between Somerset Street and Watchung Avenue. Copies of photographs by Paul Collier and Harold Morse document the properties discussed in the real estate records.

Also included are records related to the Watching Nature Club of Plainfield, NJ. Club records include administrative papers, membership records, correspondence, programs, and event materials.

In addition, there is a self-published 2003 calendar with Pittis family photographs from the 1850s through the early 2000s. An accompanying holiday newsletter provides genealogical information and photo identifications.

Additional donations to the archive made by Mr. Pittis include rare drawings, blueprints, early Plainfield maps, historic Plainfield photographs, and numerous historical files of Plainfield organizations such as the Musical Club, the Outdoor Arts Festival, and the Plainfield Business Association.

Series 1: Watchung Nature Club of Plainfield, NJ [1943-1962]



Series Description

Series 1 contains administrative and program-related records of the Watchung Nature Club. The Club strove to unite those interested in nature and the great outdoors. It presented the members with an opportunity for fellowship and experience sharing, as well as encouraged the conservation of natural resources. The annual program included club meetings during which lectures or slide presentations were given. In addition, the club sponsored numerous field excursions and camping trips throughout the year. The administrative files include correspondence, membership lists, constitutions and by-laws. Additional files contain membership cards once belonging to Mr. Bertram Pittis (Albert's brother), annual programs, event records for dinners and tours

including those for the Audubon Society, meeting announcements, and (photocopies of) newspaper clippings. It is composed solely of paper documents and ephemera.

Arrangement

Series 1 is arranged chronologically by subject, and fills six folders.

Series 2: Real Estate Records [1926-1968]



Series Description

Series 2 contains documents regarding business-related real estate holdings of the East Front Street Realty Company. Included in this series are a copy of a rare mill race map of East Front Street between Somerset Street and Watchung Avenue. Also included are records and legal documents regarding renovations made to shops along Fairchild's Alley located on East Front Street and Watchung Avenue, namely the following addresses:

- 129-133 East Front Street (Ideal Shop)
- 157-161 East Front Street
- 168-170 East Front Street (Surprise Store, *photo above*)
- 173 East Front Street (Stanley Flowers)
- 102 & 103 Watchung Avenue (Guardian Loan Company, St. Joseph's Gift Shop and a cosmetic studio

Photographs (photocopies) document the Church Street right of way, as well as several commercial sites along East Front Street, Watching Avenue, and West Front Street. Four 1980s photographs of East Front Street properties were removed from acidic poster board. All original photographs are housed with the general Historical Photograph Collection. This series is composed solely of paper documents and photographs.

Series 3 contains a holiday newsletter and self-published calendar with Pittis family photographs and genealogical information.
