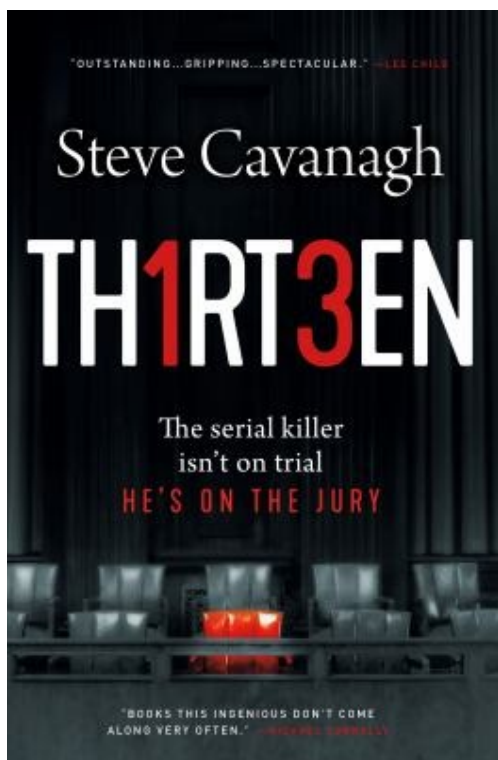


## Hyperlinks for Legal Thrillers

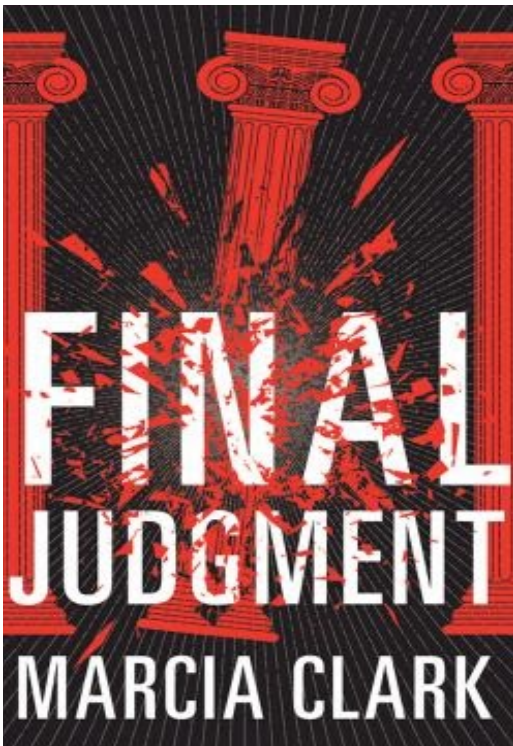

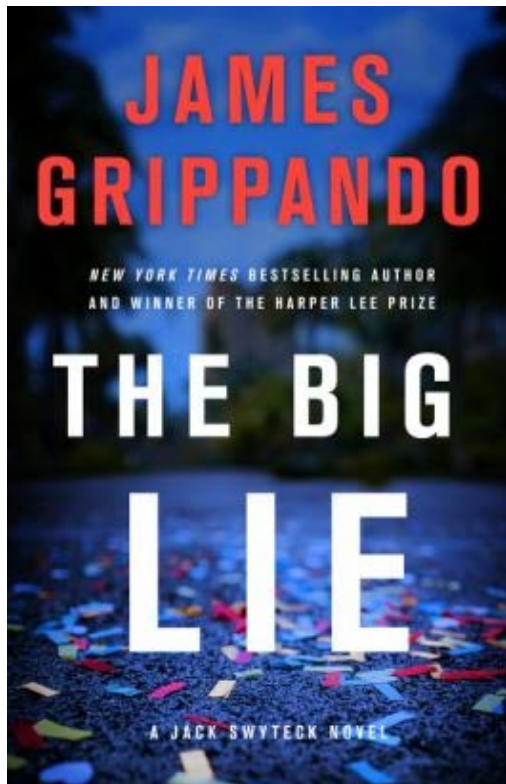
The Substitution Order

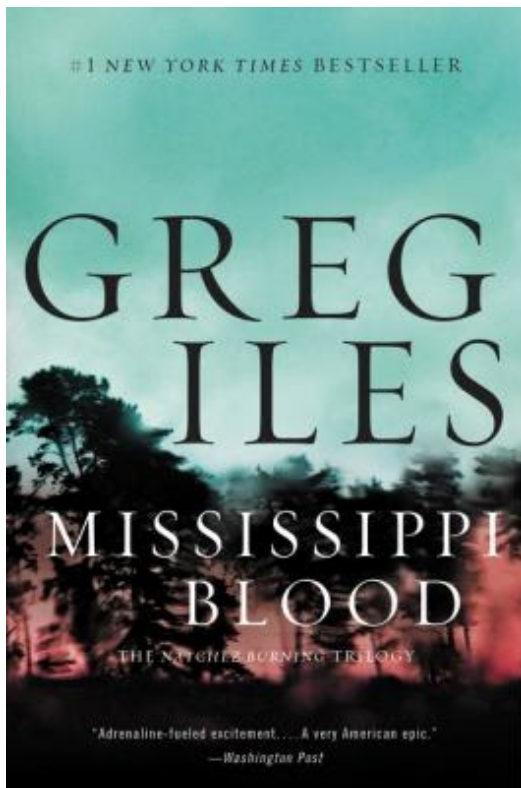

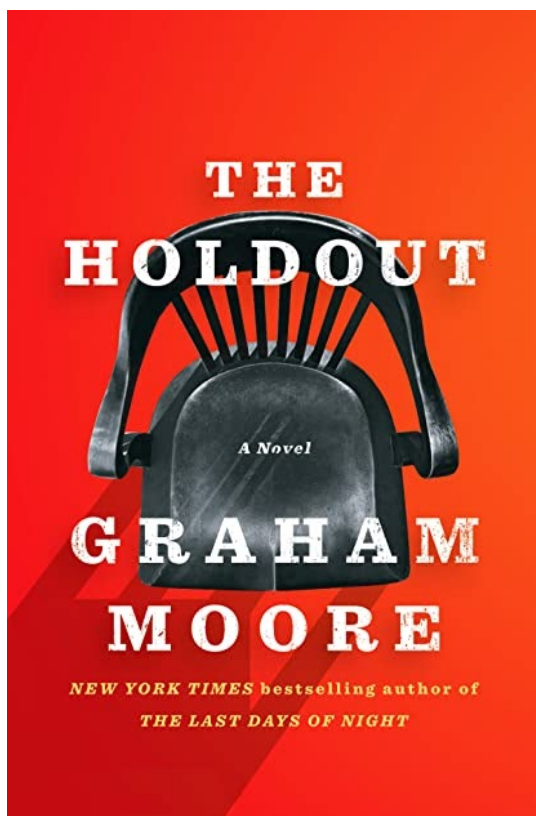

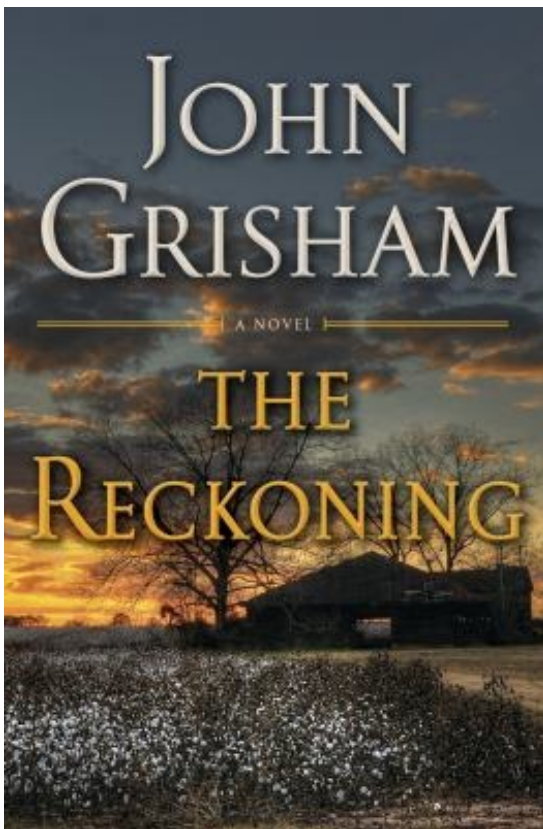
